By signing this application you are giving Farm Rescue committee members permission to obtain and review your financial records and/or credit report to determine your eligibility for assistance from Farm Rescue. You also authorize Farm Rescue committee members to contact businesses, financial institutions and other agencies to verify credit report entries and any other information that you have provided.

The process of selecting farmers who will receive assistance is based on many factors, which include, but are not limited to; farm management, geographical, financial, logistical and weather related considerations. Farm Rescue prohibits discrimination in its program on the basis of race, color, national origin, sex, religion, age, political beliefs, sexual orientation or marital status.

All statements and documents are true and accurate to the best of my knowledge. I understand that any misrepresentation will void eligibility for assistance from Farm Rescue. "I/we hereby release Farm Rescue and further agree to indemnify Farm Rescue, its officers, committee members, volunteers and agents acting in its behalf, and to hold the same harmless from and against all claims, demands and liabilities, actions and causes of action and loss or damage, whatsoever, arising out of this application for and receipt of assistance from Farm Rescue to me/us.
